**Temporary Closure
Sophia Parkway Vehicle Access and
Mormon Island Auxiliary Dam Crossing**

The Sophia Parkway Vehicle Access and Mormon Island Auxiliary Dam (MIAD) Crossing within Folsom State Recreation Area as identified on the attached map, will be temporarily closed to public entry beginning February 14, 2024, until further notice. For the safety of the visiting public, these areas are closed due to the Folsom Dam Raise Project.

Bicycle and foot traffic will be permitted on dirt trails that exist below and parallel to the MIAD. See the map for details.

Exceptions:

1. Employees, officers, contractors, lessees, and permittees of the State Department of Parks and Recreation, US Bureau of Reclamation, Army Corp. of Engineers, Contractors, entering the area on official business.
2. Those non-employees accompanied by the above-described officials who may be in the area on official business.
3. A direct route below MIAD will be provided for public access to and connecting Folsom Point and Browns Ravine.

This order is in effect for the health and safety of persons, property, and resources.

Exceptions to this order may only be granted in writing by the Gold Fields District Superintendent at 7755 Folsom-Auburn Road, Folsom, CA 95630.
Nothing herein shall be construed in derogation of other provisions of law.
